AMENDMENT NO. 1 TO INTERLOCAL AGREEMENT TO PROVIDE A VETERANS IN PREVENTION PROGRAM

This Amendment No. 1 to that certain Interlocal Agreement between Public Hospital District No. 2 and South County Fire to provide a Veterans in Prevention Program ("Agreement") dated January 9, 2020 is made by and between Public Hospital District No. 2, Snohomish County, Washington ("PHD2"), a public hospital district formed under Chapter 70.44 RCW and South County Fire ("SCF"), a fire protection district formed under Chapter 52 RCW.

WHEREAS, the possible reportable outcomes of the Agreement have changed due to unforeseen circumstances; and

WHEREAS, Section 7.4 of the Agreement authorizes the parties to amend the Agreement with a written instrument signed by both parties; and

WHEREAS, the parties to the Agreement agree that it is in the best interests of both to modify the agreed upon measurable outcomes to be accomplished;

NOW, THEREFORE, for and in consideration of the mutual benefits conferred on both parties, the parties agree to Amendment No. 1 as follows:

- **Section 6 (Obligations of South County Fire)**, subsections 6.2 and 6.4 of the Agreement are amended to read as follows:
 - **6.2** SCF will provide the program outlined in section 6.1 to at least 75 unduplicated individuals in 2020 and 500 unduplicated individuals in 2021 and 2022. SCF will enroll 30 individuals in the Connect Calls Program in 2020 and 100 individuals in 2021 and 2022. SCF will provide flu shots to 200 vulnerable adults in at least 20 care facilities in 2020.
 - **6.4** Using templates provided by PHD2, SCF will track and report program participants' progress against the following outcomes: 1.) the number of individuals served by the Fall Prevention, Connect Calls, and First Responder Influenza Vaccination Clinic Initiative Programs 2.) the number and percent of individuals that have their needs met for all programs 3.) the number and percent of individuals who no longer contact 911 or require Emergency Department visits. 4) the number and names of the care facilities served by the First Responder Influenza Vaccination Clinic Initiative Program.

EXCEPT AS EXPRESSLY MODIFIED IN THIS AMENDMENT NO. 1, ALL TERMS AND CONDITIONS OF THE AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT.
